Private sector in COMESA should consider climate financing as a huge investment opportunity in the region. That said, efforts must be made to lower the cost of capital to invest in green projects. As you are all aware, the Inaugural *Africa Climate Summit 2023*, called for a new financial focus on climate change.

It is imperative that we prioritize greening our investment as we scale up industrialisation efforts in an endeavour to boost intra and inter COMESA trade. Our research efforts should lead in proposing innovative green investment options, futures and derivatives tailored to finding lasting solutions to our region's socioeconomic problems.
